**GERMAN VARSITY** | GC GEMS GmbH, having its principal address at Vaalser Strasse 460, 52074 Aachen, Germany (hereinafter referred to as "GV", which expression shall unless repugnant to the meaning thereof, mean and include its successors and permitted assigns).

German Varsity is a collaborative Organization based out of Germany between leading German university and Global German Industry Partners. It is involved in Capacity Building Talent required for new age technologies from Robotics, Automation, Al ML AR VR, Cloud, IOT and E-mobility domain expertise. German Varsity develops advanced curriculum with Industry immersive experience which is implemented through managed LMS in both online/ offline and hybrid mode of delivery.

(First Party and Second Party are here in after jointly referred to as 'Parties' and individually as 'Party')

#### **WHEREAS**

ABESIT College of Engineering or ABESIT is a private engineering college located in Ghaziabad, Uttar Pradesh known traditionally for its education and research in engineering. The college is affiliated to Dr. A.P.J. Abdul Kalam Technical University, Lucknow. ABESIT is situated on NE-3, Near Crossing Republik, Ghaziabad. The college was founded in 2007 by Ved Foundation and provides bachelor courses in various Engineering & technology streams. Since the institute is affiliated to Dr.A.P.J. Abdul Kalam Technical University, Lucknow, the students are admitted on the basis of State Entrance Examination-APJAKTU(commonly known as UPSEE).

#### SCOPE OF THE MOU

This MOU details the modalities and general conditions regarding collaboration between ABES Institute of technology (ABESIT) and German Varsity (GV).

### ABESIT and German Varsity for collaborating for:

- 1. Opportunity for engineering students to have cutting edge training on the German industry in cooperation with several German universities and partners.
- 2. International training and exchange program to enhance the technical skills of future 4.0 technology and career opportunities for students in Germany.
- 3. To Introduce European opportunities for PG courses

Without any prejudice to prevailing rules and regulations in ABESIT and German Varsity without any disregard to any mechanism evolved and approved by the ABESIT and German Varsity. The areas of cooperation can be extended through mutual consent.

#### **SCOPEANDTERMSOFINTERACTIONS**

Both ABESIT and German Varsity shall encourage Education, and Implementation of efficient activities in the following arrangements:

- a. Provide learning opportunities for students through exchange programs.
- b. Provide resources for learning needs.
- c. Exchange programs to advance knowledge in Al, Cloud Computing, Data Analytics, Accelerated Computing, Graphics and Simulation, Machine learning and data science in disciples like robotics, autonomous vehicles, and healthcare etc.,
- d. Organization of joint Hackathon Activities
- e. Organization of joint Faculty Development Program Activities.
- f. Organization of joint Internship Programs, Prototype Implementation and Project Consultancy activities.

#### **ROLES ANDRESPONSIBILITIES**

#### ABESIT:

- To allocate Faculty members as a coordinator and to work as a SPOC (Single Point of Contact) between parties.
- To arrange workshops on specified domain.

#### **German Varsity:**

- Hosting of orientation programs for participating students.
- To arrange Industry-interaction workshops, Faculty Development Programs, Industry Conclave and Hackathon activities to first party students and faculty.
- To arrange technical resource people for conference, workshops, seminar etc., arranged by first party.
- Internship Assistance.

## CO-ORDINATION OF THE PROGRAMME INCLUDING FINANCIAL ARRANGEMENTS

- a. The collaborative programme between ABESIT and German Varsity shall be coordinated by a coordination committee appointed by Director's/Principal of both the parties.
- b. Financial arrangements for any other specific collaboration will be decided on a case-to-case basis and brought on record in each case after due approval from heads of both the parties.

#### **EFFECTIVE DATE AND DURATION OF MOU**

- a. This MOU shall be effective from the date of its approval by competent authorities at both ends.
- b. The duration of the MOU shall be for a period of 3 years from the effective date.
- c. During its tenancy, the MOU may be extended or terminated by a prior notice of not less than six months by either party. However, termination of the MOU will not in any manner affect the interests of the students/faculty/scientists who have been admitted to pursue a program under the MOU.
- Any clause or article of the MOU may be modified or amended by mutual agreement of German Varsity and ABESIT.

#### CONFIDENTIALITY

During the tenure of the MOU both ABESIT and German Varsity will maintain strict confidentiality and prevent disclosure of all the information and data exchanged under the scope of this MOU for any purpose other than in accordance with this MOU.

Both ABESIT and German Varsity shall bind their respective personnel who come into possession or knowledge of any confidential information not to disclose the same to third parties without written approval of the disclosing party or use such confidential information for any use other than intended under this agreement or PROJECTS.

Further both ABESIT and German Varsity shall put in place adequate and reasonable measures to keep and store confidential information secure so as to prevent any unauthorized use.

#### INTELLECTUAL PROPERTY

Nothing contained in this MOU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copyrights and designs) of the other Party.
