#### 4. PARTY B RESPONSIBILITIES UNDER THIS MOU

  - c) Live Project (Intermediate Level) phase
  - d) Live Project (Advance Level) phase
- 3. The exact timeline of the phases of program will be shared by Party A with the management of Party B
- 4. Payment will be released in 4 installments of 25% of the total amount
- 5. The payment will be released on the starting day of each phase

# 5. IT IS MUTUALLY UNDERSTOOD AND AGREED BY AND BETWEEN THE PARTIES THAT:

- a) Party A and Party B can suggest the modification for the program and can apply on mutual understanding.
- b) Termination of the program can be done on the mutual understanding of both the parties.
